Dear Sirs,

I am writing to place before the European Court of Human Rights, my divorce case, upon which I exhausted all legal channels in English Courts at the final hearing which was on 25/02/2011. I understand I have 6 months to take my case to the European court of Human rights and I would like to do that please.

I enclose judgments and notes as requested by the registrar.

Decree Nisi was issued in 31 Aug 2007.

I got ill in Nov 2008 and an Official Solicitor was appointed to represent my early in 2009.

The court order joint valuations which was not done properly as was one sided valuations.

In Sept 2009 my personal assets which are ALL in Greece, was overvalued by 1 million pounds by the wife to claim a bigger state.

Because Those valuations was not translated in English fully. Only the 1st page of each of 10 pages valuation was translated which confirms the content of the equity and the value of the equity. Essential information was kept away from the judge and the judge gave the wrong order. Garbage in THEN garbage out.

Because: Two equities valued for half a million pounds was not my current equities since year 2000 (divorce happened in 2007). I was ordered to pay 600,000 pounds when all my equities worth 300,000 pounds. I was seriously ill and unable to explain the errors at the final hearing. I was not present. The Official Solicitor did not know my case.


Because: The order is against the Greek law in which all my assets are located. Is not compatible with the public policy. Again garbage in gives a not executable order in Greece. The Greek law where my equities are was not taken at all into any consideration, which makes the order WRONG and against the law in which the assets are BASED.

Because: the law was used inaccurately, I am facing an order which is humanly impossible to follow and obey and resolve. I therefore apply in your kind court and I ask please for an application to complete and sent to your court with the full bundle of all documents.

Because: I am Greek origin have a Greek passport, I am a Greek domicile. I was permanent resident in Greece more than 100 days in year 2007 before the "decree nisi" was ordered and my assets are based in Greece and the Greek law has and carry some effect on the final order of the 9/10/2009 which is not executable in Greece and is not compatible with the public policy I wish please the European Court of Human Rights to examine my case.

Your attention is drawn to the fact that it is the date of introduction that is decisive for compliance with the time-limit set out in Article 35 § 1 of the Convention (see paragraph 18 in enclosed notes to applicants).

For safety reasons, any object sent to the Court without having been expressly requested by the Registry will be destroyed immediately together with the cover letter. If you consider sending documents other than on paper, you should first get in touch with the Registry.

The file opened in respect of your communication will be destroyed without being submitted for judicial decision, six months from the date of the present letter, unless the duly completed application form has been received in the meantime.
